# 117/15 REQUESTS FOR PRESENTATIONS BY DEVELOPERS – CONSIDER MAKING A RECOMMENDATION TO COUNCIL

As the Town Council is being approached by developers to make presentations on possible developments, does the Town Council wish to continue allowing this, as in the recent case of the Astwick Road presentation for proposed bungalows, it appears that the landowner was not aware of the developer's intentions. The Town Council also needs to be assured that it is not being put in a position of pre-judging before any application is lodged.

**RECOMMENDED** that Stotfold Town Council and its Planning Committee will not meet with developers wishing to informally discuss a possible planning application before a formal planning application has been submitted to Central Beds Council and passed to us for comment in the usual way. This is to avoid any possibility of Stotfold Town Council being viewed as having prejudged a planning application and to avoid developers gaining a wrong impression. Stotfold Town Council is able to offer developers the hire of the Simpson Centre or Memorial hall if they wish to make a presentation to the residents of Stotfold, at which Councillors can attend if they wish to gather information on a personal basis. Stotfold Town Council would endeavour to publicise such events to ensure residents had ample opportunity to gather information and ask questions about any proposed development.

Town Council comments: We feel that the amendments to the submitted plans are so minor that we repeat our previous comments - Object to this proposal as we consider it to be an overdevelopment of the site. Vehicles entering and leaving each dwelling will cause increased traffic and pedestrian safety issues - multiple vehicles crossing a well-used footway, emergence of traffic onto an already busy road, adjacent to a cross-road junction (Regent Street/Common Road/The Green). Should the proposal be approved, we revert to our previous comment for this site, requiring double yellow lines are placed on Regent Street outside the proposed dwellings to preserve the vision splay.
